Membership

CMRS welcomes all persons who enjoy the hobby of model railroading. We encourage those who are interested and willing to contribute their time and skills for the construction, maintenance or operation of our model railroad and our building, to submit an application for membership. Benefits of membership include: new friends with a common interest, the opportunity to improve modeling skills and learn new techniques, and of course the pleasure of operating trains on a world-class layout.

Categories of Membership

- **Senior Membership:**
Senior Membership provides: use of the club facilities for their intended purposes, voting privileges, the opportunity to serve as an Officer, Board member, Committee Chair or Superintendent, and all other privileges and responsibilities accorded a Senior Member, including a key to the building. Senior members must be at least 18 years of age. To maintain membership privileges your dues and assessments must be kept current. Dues for Senior Members are \$60.00 per quarter (3 months). **Dues are payable at the beginning of each quarter.**
- **Family membership:**
See page 4 for details.
- **Youth Membership:**
Youth Membership is available for persons 14 thru 17 years of age. Youth applicants must have the written and signed consent and permission of and from their legal guardian. Furthermore, the legal guardian of each youth must agree to be responsible for said Youth Member, and be present and supervise said Youth Member at any and all events or activities in which the Youth Member participates. Dues for Youth Members are \$15.00 per quarter. The Consent Form for Youth Members (page 4 of this application) must be signed by the Youth Applicant's parent or legal guardian. Upon reaching the age of 18, a Youth Member becomes eligible for elevation to Senior or Family Membership. Youth Members do not have a probation period as long as they were a Youth Member for more than six months.

Application process for Membership: The process begins with the submission of a completed Application and the payment of three months dues in advance. This will enroll you as a Probationary Member. This period allows a new member to become acquainted with the club and its members, and the club to become familiar with the Probationary Member. It also allows the member to demonstrate their skills and willingness to participate in the projects and activities of the club. Probationary members are welcome at the club any time there are Senior Members present. During this period, you should also read the CMRS Bylaws and become familiar with CMRS Standing Rules. **Dues must be kept current at all times, including during the Probation period.**

Upon completion of a minimum six-month probationary period, your application and participation in the club will be reviewed by the CMRS Board of Directors. The Board may then present your name to the membership, as stated in the Bylaws, for a vote of acceptance. You will then become responsible for quarterly dues of \$60.00, starting from the date of application, and the payment of a one-time Building Fee of \$50.00, which is due upon acceptance as a Senior member.

As a Youth, Probationary, Family, or Senior Member, you agree to abide by and respect the Bylaws, Standing Rules, and all Policies and Procedures of CMRS.

Family Membership Information

Family membership is available for two or more members of an immediate family (those members of a family having the same primary residence). Family membership is composed of one Primary Family Member and one or more Associate Family Member(s).

The Primary Family Member has the following privileges:

- One card key to the building, which can be shared amongst the members of the family.
- The opportunity to serve as an Officer, Board member, or Superintendent (subject to club rules).
- All the privileges of a Senior Member.

The Associate Family Members have the following privileges:

- Use of the shared card key to the building.
- Participation in club events.
- Any Family member under the age of 18 must be accompanied by an adult Family member at any time they are at the club. Please sign the consent form on page 5 if any Family member is under the age of 18.
